The intent of the Lawton Undergraduate Multicultural Retention Grant Program (LUMRG) is to provide financial assistance to designated minority undergraduate students to improve their opportunities for retention and graduation and lessen the burden of student debt.

- 1) **Funding limits will be awarded based on a students UW-Stout cumulative GPA**
- 2) **Funding limit awards will be based on the following GPA guidelines:**
 - **\$2,400 per year or \$1,200 per semester if GPA is 2.5 or higher**

Application process:

 - **Enrollment Clarification**
 - **Priority consideration deadline: March 13, 2009**

Certification process:

- 1) **Have meet with your Multicultural Student Services advisor (MSS) fall term**
 - **Continuation of LUMRG requires recipients to meet with their MSS advisor once per term**
- 2) **Meet GPA requirement**
 - **Submit unofficial transcripts to your MSS advisor by January 15, 2010 to verify academic satisfactory progress**
 - **MSS will verify cumulative GPA at the end of fall semester to determine spring eligibility**
- 3) **Set up appointment to meet with your MSS advisor for spring semester**
